# **MEMORANDUM OF AGREEMENT**

The Development Agreement and City Ordinance No. 2004-01 (the "Ordinance") passed by the City Council of the City in conjunction with the Development Agreement impose certain obligations on the Developers, and their respective successors and assigns, respecting the subdivision, development and sale of the Property. Additionally, the Development Agreement and Ordinance impose certain covenants, conditions and restrictions on the Property and define the permitted uses thereof.






