GRANTED, SOLD AND CONVEYED, and by these presents do GRANT, SELL AND CONVEY, subject to the reservations hereinafter set forth, unto the said MCRCY S. STRAUS, JR., of the County of Harris, State of Texas, all that Mertain lot, tract or parcel of land, together with all improvements there we, lying and being situated in the County of Harris, State of Texas, described as follows:

A part of the Daniel O'Neal Survey, Abstract No. 617 in Harris County, Texas, being a portion of the O. J. Speare et al tract and being more particularly described as follows, to-wit:

BEGINNING at a point in the center line of the pavement of the Old East Montgomery Road, said point being in the present roadway of U. S. Highway No. 75, and being the Southeast corner of said Daniel O'Neal Survey;

THENCE West, along the southerly line of the said Daniel O'Neal Survey as partially fenced and generally recognized and Ecross said U. S. Highway No. 75, a distance of 158.0 feet to a 3/4 inch pipe in the westerly line of said U. S. Highway No. 75 as fenced, from which a 16 inch Sweet Gum marked X bears North 11°10' East 40.5 feet and a 24 inch Pin Oak marked X bears North 33°45' West 13.7 feet; said point being a point in the northeasterly corner of a tract of land now or formerly of J. THENCE West, along a fence dividing the said Daniel O'Newl Survey and B.B.B. & C. Ry. Co. Surveys and of the said J. M. Blake tract and the said O. J. Spears et al tract, at 237.0 feet cross the center line of the north fork of said Greens Bayou, at 1136.9 feet cross the underground cable of the Southwestern Bell Telephone Company, at 3058.4 feet cross the center line of the Sinclair Pipe Line Company's right of way, in all 3891.2 feet to and old "T" Rail in the easterly line of the John Schnell Survey from which a 16 inch Red Oak West A bears South 71°05' West 14.0 feet and a ten inch Red Oak Warked X bears North 21°10' West 53.7 feet; said point being

THENCE North $89^{\circ}54$ ' East 1628.90 feet to a 3/4 inch pipe for corner;

THENCE South, at 813.38 feet pass a 3/4 inch pipe marking the northwesterly corner of a 9.04 acre tract now owned by C. W. Holt and wife, at 1002.38 feet pass a 1/2 inch pipe marking the southwesterly corner of said Holt Tract, in all 1438.59 feet to a 3/4 inch pipe for corner;

THENCE North $89^{\circ}54^{\circ}$ East 2191.55 feet to a 3/4 inch pipe in the westerly line of said U. S. Highway No. 75 as fenced;

THENCE in a southerly direction along the westerly line of said U. S. Highway No. 75 as fenced and following a 1° curve to the right, the said curve being tangent to the course of South 00°06' East, and having a radius of 5730.0 feet, a distance of \$12.5 feet to a point of tangent of said curve;

THENCE still following the westerly line of said U. 3. Highway No. 75 as fenced, South 00°06' East 737.5 feet to the point or place of beginning of this tract; containing 200 acres of land, as shown by a survey made by Λ . C. Stimson, C.E., in July and August, 1952.

There is reserved by Grantor herein, O. J. Spears./an undivided 1/16th perpetual royalty interest (being 1/2 of the customary 1/8th royalty) in and to all of the oil. gas and other minerals in, on and under, and that may be produced and mined from the above described property and premises, it being understood and agreed, however, that the Grantors, their heirs and assigns, shall not be entitled to participate in any bonus or bonuses which the Grantee, his heirs or assigns, shall receive for any future lease, nor to participate in any rental to be paid for the privilege of deferring the commencement of a well under any lease, present or hereafter, nor shall it be necessary for the Grantors, their heirs, legal representatives or assigns, to join in the execution of any lease covering said land hereinafter given by the Grantee, his heirs or assigns; and the other Grantors herein do hereby expressly declare and consent that the said 1/16th royalty interest herein reserved only by 0. J. Spears shall be in and considered as a full 1/2 of the whole of the customary 1/8th royalty interest in and to all of said oil, gas and other minerals in, on and under and that may be produced from the whole of the above


