WHEREAS, I have heretofore executed, signed, and acknowledged the FIRST AMENDMENT TO RESTRICTIONS FOR BRIARCROFT ADDITION A SUBDIVISION IN HARRIS COUNTY, TEXAS as proposed by the Board of Directors of Briarcroft Property Owners, Inc., containing among other provisions, a provision providing that the Restriction may only be amended by the approval of 85% of the Lot owners in Briarcroft Addition; (hereinafter the "Board of Directors Proposal"); and

WHEREAS, I have also heretofore executed, signed and acknowledged the FIRST AMENDMENT TO RESTRICTIONS FOR BRIARCROFT, A SUBDIVISION IN HARRIS COUNTY, TEXAS, as proposed by a Lot owner in Briarcroft Addition, containing among other provisions, a provision providing that the Restrictions may only be amended by the approval of 70% of the Lot owners in Briarcroft Addition (hereinafter the "Alternate Proposal"); and

WHEREAS, I desire to ratify, reaffirm, and confirm my signature on the Board of Directors Proposal and rescind my signature on the ~~Board of Directors Proposal~~ ^{Alternate Proposal} Two.

Now therefore, I do hereby ratify and confirm my signature on the FIRST AMENDMENT TO RESTRICTIONS FOR BRIARCROFT ADDITION A SUBDIVISION IN HARRIS COUNTY, TEXAS, the Board of Directors Proposal and rescind my signature for all purposes on THE FIRST AMENDMENT TO RESTRICTIONS FOR BRIARCROFT, A SUBDIVISION IN HARRIS COUNTY, TEXAS, the Alternate Proposal.


